### CIRCULAR

#### **Sub: Decision for the Mode of End-Semester Examination (Odd Session) 2021-22.**

**Preamble:** With reference to End Semester Examination, the University communicated well in advance to the students for **On Campus Examination** vide Circular No. GSFCU/EXAM/CIR/2021-22/13 Dated 07.10.2021.

Further, many representations from the students and parents were made and requested for the postponement of Examination because of accommodation issues.

The GSFC Management considered the genuine request of students staying outside Vadodara and postponed the Examination of B. Tech/BBA Final Year for two-weeks and, B. Tech Third Year for one-week, and the same has rescheduled from 29<sup>th</sup> Nov. 2021 and communicated vide Circular No. GSFCU/EXAM/CIR/2021-22/14 dated 03.11.2021.

Further, few students from B.Tech Chemical Engineering have been requesting for the on-line examination due to various reasons, and students from other disciplines are also joining them.


The reasons mentioned by students have been reviewed by the committee as follows:

1. Many students have already found PG accommodation and are properly settled in the city. Some of the students from UP, Bihar, West Bengal, Jharkhand have already come back to the campus for the End Semester Examination.
2. As such, there is no surge in COVID-19 cases as per the report appeared in Times of India, dated 16.11.2021, which mentions only 20 to 25 cases a day in the whole state of Gujarat. As on date there are 220 cases in the state as per the News Agency. Also, as per the report on the website of Vadodara Municipal Corporation as on 16.11.2021, there are only 4 to 6 cases a day in Vadodara City.
3. The university adopted hybrid mode of teaching and many students have attended classes on campus. It was voluntary for the students to attend classes on-line as well as on-campus.



**Decision:** In view of the representation made by few students and considering the larger interest of the students' community, following decision has been taken:

1. The university will conduct the End Semester Examination including practical examination On-campus (offline) as per schedule i.e., from 29<sup>th</sup> Nov. 2021 onwards.
2. The university will conduct a Special Examination (On-campus) by 28<sup>th</sup> February 2022 for all those students who are unable to appear in the On-campus examination commencing from 29<sup>th</sup> Nov. 2021.
3. All those students who are not appearing in Examination from 29<sup>th</sup> Nov. 2021, and desirous to appear in Special Examination in February 2022 are required to inform the University in prescribed Google Form (Link: <https://forms.gle/efLcu6WBxsXH2xvj9>) then only they will be allowed to appear in Special Examination in February 2022.
4. The university will prepare the schedule of special examination after considering the GATE 2022 examination schedule.
5. All those students who wish to opt for February 2022 special examination will be considered as Regular and First attempt.
6. Those students who are unable to appear in on campus examination in Nov-Dec 2021, will have to inform the University compulsorily for their absence, otherwise their absence will be treated as ATKT and the same will be scheduled during May-June 2022.
7. Only those students who do not want to appear in the Nov-Dec 2021 examination are required to fill up the form, else it will be treated as their acceptance to appear in the Nov-Dec 2021 examination.
8. The students, after opting to appear in the end semester examination during Nov-Dec 2021 will have to appear in all the courses/subjects Theory and Practical examinations, otherwise the absence in any course/subject will be considered as ATKT.
9. The ATKT Examination scheduled from 04<sup>th</sup> -22<sup>nd</sup> December, 2021, will be conducted as per the schedule (on-campus) and no special ATKT examination will be conducted for the same.
10. All the students are required to follow COVID-19 guidelines and must be present with Aarogya-Setu App for verification.
