**Eligibility Norms**

1. Distinguished experts who have made remarkable contributions in their professions from various fields such as engineering, science, technology, entrepreneurship, commerce, social sciences, media, literature, fine arts, civil services, armed forces, legal profession, community development, panchayati raj, rural development, watershed development, water-harvesting, organic farming, small green energy systems, municipal planning, community participation, gender budgeting/planning, inclusive development of tribals and public administration among others.
2. Those who have proven expertise in their specific profession or role with at least 15 years of service/experience, preferably at a senior level.
3. A formal academic qualification is not essential for this position if you have exemplary professional practice in lieu.

4. These experts will also be exempted from the requirement of publications and other eligibility criteria stipulated for the recruitment of faculty members at the Professor level.

**Specialization**

**General Conditions:**

1. The engagement of Professor of Practice will be for a fixed term.
2. The engagement of Professor of Practice will be exclusive of the sanctioned posts of a GSFC University. It will not affect the number of sanctioned posts and the recruitment of regular faculty members.
3. Professor of Practice is not open for those in teaching profession-serving or retired.

**Categories of Engagement:**

- i. Professor of Practice funded by Industries.
- ii. Professor of Practice funded by GSFC University.

**Selection Procedure**

Nominations/Applications from eminent experts shall be invited for Professor of Practice positions. Selection committee shall evaluate nominations or candidatures as per selection criteria

**Tenure**

The engagement may be initially for up to one year. At the end of the initial engagement or subsequent extension, the University will make an assessment and take the decision about extension.
