

Discipline in Fertilizernagar Campus by GSFC University Students

With the increased strength of students enrolled at GSFC University, the discipline in the Fertilizernagar Campus and Safety on roads have become an important issue and cause of concern in vicinity of various schools and hostels namely – SOS, SOM, SOT, and Vikram Sarabhai / Kasturba Gandhi Bhavans. Incidents relating violation of road safety rules are also reported in the recent past and consequently few incidents of near miss accident have also been reported. Students have been observed riding two wheelers without safety helmets at speeds exceeding the permitted limits (also triple riding at times). This is cause of concern for safety and security of all i.e. students, GSFC-U employees, GSFC Ltd employees and their families.

Students of university residing in Vikram Sarabhai / Kasturba Gandhi Bhavans should maintain discipline in their behaviour and are expected to show proper concern to the surroundings, so that reputation of university is not tarnished under any circumstances, which may affect their contemporaries and successors. Moreover, since hostels are located inside Fertilizernagar township campus surrounded by residential quarters where GSFC Ltd employees and families are residing, it is imperative to maintain discipline and decency.

Also, university students have been provided access to all the health and recreational facilities of GSFC Ltd which is unique and noteworthy gesture. Students are once again requested to utilize these sports facilities with utmost care and judiciously within the allotted time schedules strictly without loitering around in the campus.

Following guidelines are to be followed strictly by one and all:

- (1) All GSFC University students will strictly continue to utilize Dashrath gate only for coming in and going out of the campus.
- (2) Students are requested to compulsorily wear safety helmets while riding inside the Fertilizernagar Township campus and to observe all traffic rules.
- (3) Students are requested to compulsorily park their two wheelers in designated parking areas allocated opposite SOS / SOT / New Lab Building basement parking.



(4) Any student loitering in Fertilizernagar Township will be considered as misconduct and will be dealt with accordingly including disciplinary actions against erring students by GSFC University authorities / GSFC Security department.

University is an Institution of higher learning where objective standard of conduct and behaviour are expected from students while in campus or outside the campus. Violent, indecent, disorderly, threatening or offensive behaviour or language (whether expressed orally or in writing, including electronically) whilst on university premises or engaged in any university activity or otherwise affecting or concerning a university student or employee of GSFC Ltd, will be viewed very seriously by the university management. Any complaint of indecent behaviour / noisy situation from neighbours, will result in severe disciplinary action.

Mr. C. B. Chauhan, Warden is being instructed to implement the above strictly and to take weekly round along with the GSFC Security personal to check effectiveness of the circular with immediate effect and bring any discipline related matters to immediate notice of GSFC-U management.
