



MEMORANDUM OF UNDERSTANDING (MOU) FOR INDUSTRIAL INTERNSHIP /CAMPUS PLACEMENT.

GSFC University has introduced a unique practice of providing intensive Industrial Internship for every student in each semester with an objective of making them Industry ready and employable.

Therefore, GSFC University has approached Aum Creatives having its registered office at 483, Kothi Rd, near Government Press and Stationery, Anandpura, Vadodara, Gujarat 390001 with a request to provide the Industrial Internship as per the Students Industrial Internship Manual of the University.

- 4) GSFC University and Aum Creatives shall appoint a Faculty mentor and Industry mentor as per the Students Industrial Internship Manual for effective implementation of the Industrial Internship.
- 5) GSFC University shall ensure to fulfil all safety and security related compliances of the Aum Creatives during the period of Industrial Internship and shall cover all the students under the Group accident Insurance Policy for an amount of Rs. 1.00 Lakhs for each student.



- 6) This MOU has been executed with the sole purpose of establishing an industry linkages of the University with Aum Creatives without creating any legal obligation on either party to this MOU.

Besides Industrial Internship, we may also associate with GSFC University to conduct Expert Talk/Placement Drive/Campus Placement as and when required without any obligation on either party.
