

## MEMORANDUM OF UNDERSTANDING (MOU) FOR INDUSTRIAL INTERNSHIP /CAMPUS PLACEMENT.

- 4) GSFC University and C.P DESIGNING shall appoint a Faculty mentor and Industry mentor as per the Students Industrial Internship Manual for effective implementation of the Industrial Internship.
- 5) GSFC University shall ensure to fulfil all safety and security related compliances of the C.P DESIGNING during the period of Industrial Internship and shall cover all the students under the Group accident Insurance Policy for an amount of Rs. 1.00 Lakhs for each student.





6) This MOU has been executed with the sole purpose of establishing an industry linkages of the University with C.P DESIGNING without creating any legal obligation on either party to this MOU.

Besides Industrial Internship, we may also associate with GSFC University to conduct Expert Talk/Placement Drive/Campus Placement as and when required without any obligation on either party.
